Cushing ISD Parent and Family Engagement Policy 2020-2021

Part I. GENERAL EXPECTATIONS

The Cushing ISD agrees to implement the following statutory requirements:

- The school district will put into operations programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1116 of Every Student Succeeds Act (ESSA). - 1. Cushing ISD will take the following actions to involve parents in the joint development of its districtwide parental involvement plan under section 1116 of the ESSA:

- 4. Cushing ISD will coordinate and integrate parental involvement strategies in Part A under the following other programs:

- 5. - B. Cushing ISD will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate to foster parental involvement, by:
 - ESL/ELL parent updates,
 - Autism identification materials/state conferences,
 - Provide parent education, referral and support services to help parents improve student learning in all academic areas
 - ACT testing site
 - Behavior management/Counseling
- C. Cushing ISD will, with the assistance of its school and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Region VII trainings,
 - Professional Development trainings, and
 - State conferences
- D. Cushing ISD will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, public preschool, and other programs.
